1.2 COGNITIVE BIASES: CONFIRMATION BIAS, A TENDENCY TO SEEK OUT INFORMATION CONFIRMING PRE-EXISTING BELIEFS, CAN SIGNIFICANTLY DISTORT PERCEPTION. AN INDIVIDUAL CONVINCED OF SOMEONE'S GUILT MAY MISINTERPRET EVIDENCE AND OVERLOOK EXCULPATORY DETAILS. SIMILARLY, THE AVAILABILITY HEURISTIC – RELYING ON EASILY RECALLED INFORMATION – MIGHT LEAD TO INACCURATE JUDGMENTS BASED ON SENSATIONALIZED MEDIA REPORTS OR PERSONAL EXPERIENCES.

1.3 MENTAL ILLNESS: CERTAIN MENTAL HEALTH CONDITIONS, SUCH AS DELUSIONAL DISORDERS OR FACTITIOUS DISORDER, CAN LEAD INDIVIDUALS TO FABRICATE ACCUSATIONS. THESE INDIVIDUALS GENUINELY BELIEVE THEIR ACCUSATIONS ARE TRUE, DESPITE A LACK OF EVIDENCE.

1.4 SOCIAL PRESSURE AND GROUPTHINK: SOCIAL DYNAMICS CAN PLAY A SIGNIFICANT ROLE. INDIVIDUALS MIGHT FEEL PRESSURED TO CONFORM TO GROUP NARRATIVES, PARTICULARLY IN CASES WHERE ACCUSATIONS ALIGN WITH EXISTING PREJUDICES OR SOCIETAL BIASES.
