WHILE SOME HAILED HIS WORK AS A FRESH AND INSIGHTFUL PERSPECTIVE, OTHERS CONDEMNED IT AS A SIMPLISTIC AND EVEN APOLOGETIC INTERPRETATION OF NAZI AGGRESSION.
