1.2 A HISTORICAL OVERVIEW OF ATROCITY FABRICATION

2.2 MISINFORMATION CAMPAIGNS: THE SPREAD OF FALSE NARRATIVES

THE INTERNET AND SOCIAL MEDIA HAVE DRAMATICALLY AMPLIFIED THE SPREAD OF MISINFORMATION. FALSE NARRATIVES CAN GO VIRAL, REACHING MASSIVE AUDIENCES IN A MATTER OF HOURS.
